STARTING A BUSINESS IN CERRITOS

If you are planning to start a business in Cerritos, please contact the City's Current Planning Division at (562) 916-1201 to ensure your business is a permitted use within the City. Additionally, you will need to obtain a City of Cerritos Business License. You can apply for a City business license online at www.permits.cerritos.us. For more information, please call (562) 916-1236.

A complete business license application must be submitted:

- When an individual, partnership or corporation conducts or intends to conduct business in the City of Cerritos.
- When a business moves from one location in Cerritos to another.
- When a business changes ownership.
- For each location a business occupies.
- For each type of business at a given location.

Fees:

- Most license fees are based on a flat rate.
 Some fees are based on the number of employees, square footage and number of units. For more information, please contact the Business License Division at (562) 916-1236.
- The license fee for a new business is due on or before commencement of any business activity.
- A renewal fee is due on the day the license expires. Business licenses can be renewed online at www.permits.cerritos.us.
- License fees are increased every July 1st.
 The increase is based on the March 31st
 Consumer Price Index. Fees cannot increase more than 10% each year.
