  - d. Execution of a consent and release by Golden State upon terms and conditions acceptable to the City of Cerritos, and
  - e. Grant of permits by the cities of Lakewood and Cypress, and by County Flood Control District and the Metropolitan Transportation Authority, upon terms and conditions acceptable to the City of Cerritos (COUNCIL)
- 2. Authorize the City Manager to execute the following:
  - a. All documents required by GWMA related to the DWR grant funding for the Cerritos project, and
  - b. A service agreement with Forest Lawn Memorial Park, subject to the approval of the City Attorney and pursuant to the term sheet included in the staff report, and
  - c. A professional service agreement with MCM Management Company to provide project management oversight, as it related to grant compliance for Reclaimed Waterline expansion project (COUNCIL)
- 3. Approve that the City Council has reviewed the Negative Declaration and that the Negative Declaration has been prepared in compliance with the California Environmental Quality Act (COUNCIL)
