Authorize the City Manager, or his designee, to restore said units to their original condition, extend the existing affordability and occupancy covenants for said units, and to re-sell the subject properties located at 19427 Topaz Court, Unit G, Cerritos, California, 90703 and 19423 Sapphire Court, Unit N, Cerritos, CA 90703, to qualified senior residents in accordance with recorded Agreement and Covenant Concerning Use and Resale of Residential Units and Right of First Refusal to Purchase documents (COUNCIL).
