NOTICE IS HEREBY GIVEN that the General Municipal Election is to be held in the City of Cerritos, California, on Tuesday, March 3, 2020 at which there will be submitted to the voters the following measure(s):

Shall the measure to establish a general, three-quarters percent (0.75%) local transactions and use (sales) tax, raising an estimated \$11.4 million annually, and ending when voters decide to do so, subject to independent audits and public reports of spending, to provide and maintain a high level of City services, including, but not limited to, local sheriff's and community safety, sidewalk and street maintenance and repair, tree-trimming, library services, and parks and recreation services, be adopted? NOTICE IS FURTHER GIVEN that pursuant to Article 4, Chapter 3, Division 9 of the Elections Code of the State of California, the legislative body of the City, or any member or members thereof authorized by the body, or any individual voter or bona fide association of citizens, or any combination of voters and associations, may file a written argument, not to exceed 300 words in length, accompanied by the printed name(s) and signature(s) of the author(s) submitting it, or if submitted on behalf of an organization, the name of the organization, and the printed name and signature of at least one of its principal officers who is the author of the argument, for or against the City measure(s).

NOTICE IS FURTHER GIVEN that, based upon the time reasonably necessary to prepare and print the arguments and Voter Information Guide for the election, the Cerritos City Clerk/Elections Official has fixed Thursday, October 10, 2019, 5:00 p.m., during normal office hours, as posted, as the date after which no arguments for or against the City measure may be submitted to the Cerritos City Clerk/Elections Official for printing and distribution to the voters as provided in the Article 4. Arguments shall be submitted to the Cerritos City Clerk/Elections Official, accompanied by the "Form of Statement to be filed by Author(s) of Argument" in accordance with the California Elections Code which include the printed name(s) and signature(s) of the author(s) submitting it, or if submitted on behalf of an organization, the name of the organization, and the printed name and signature of at least one of its principal officers who is the author of the argument, at the Office of the Cerritos City Clerk/Elections Official, City Hall 1<sup>st</sup> Floor, 18125 Bloomfield Avenue, Cerritos, CA 90703. Arguments may be changed or withdrawn until and including the deadline date fixed by the Cerritos City Clerk/Elections Official

NOTICE IS FURTHER GIVEN that any ordinance, impartial analysis, or direct argument filed under the authority of the elections code will be available for public examination in the Office of the Cerritos City Clerk/Elections Official for not less than 10-calendar days from the deadline for the filing of the arguments and analysis.
