有關向喜瑞都市書記官/選務官員 提交贊成或反對市議案 意見書截止日期的通知

特此通知，將於2020年3月3日（星期二）在加州喜瑞都市舉行市級普選，屆時將提出以下議案，供選民表決：

<p>是否要批准議案、設立一項普通地方交易和使用（銷售）稅，稅率為0.75%，每年預期可徵得稅款 1140萬美元，以便市政府提供和保持高水平的服務，包括但不限於本地治安和社區安全服務、街道及人行道維護和修整、修剪樹木、圖書館服務、以及公園和娛樂服務，並且該稅項隨時可由選民決定終止，對稅款使用進行獨立審計，並公開發佈支出報告？</p>	是

謹在此進一步通知，根據《加利福尼亞州選舉法典》第9篇第3章第4條，市立法機構或其授權的任何成員、或任何選民或真實的公民團體、或任何選民或團體的組合，均可提交一份書面意見書，該意見書應不超過300個英文單詞，並附有作者的名字及簽名；如果是代表團體提交意見書，則需註明團體名稱，並附有至少一位負責人兼作者的名字及簽名；陳述對市議案的贊成或反對意見。

謹在此進一步通知，基於編製和印刷意見書及《選民資訊指南》所必需的合理時間，喜瑞都市書記官/選務官員已經決定，2019年10月10日（星期四）下午5:00為根據第4條向喜瑞都市書記官/選務官員提交贊成或反對市議案意見書以便印刷並向選民分發的截止時間。意見書須提交喜瑞都市書記官/選務官員，並且按照《加利福尼亞州選舉法典》隨附《由意見書作者提交的聲明表》，包括意見書作者的姓名和簽名；如果是代表團體提交意見書，則需註明團體名稱，並附有至少一位負責人兼作者的姓名及簽名。上述文件應提交至喜瑞都市書記官/選務官員辦公室，地址是：Office of the Cerritos City Clerk/Elections Official, City Hall 1st Floor, 18125 Bloomfield Avenue, Cerritos, CA 90703在喜瑞都市書記官/選務官員決定的截止日期之前（包括截止日當天），意見書可修改或撤回。

謹在此進一步通知，任何法令、公正分析報告或根據選舉法典提交的直接意見書，均將存放在喜瑞都市書記官/選務官員辦公室供公眾查閱，供查閱時間不少於10個-日曆日，自提交意見書和分析報告的截止日期算起。
