Administrative title: Comprehensive Charter "clean-up," update and modernization	
Shall the Cerritos City Charter be amended to remove or modify provisions based on superseding and preemptive State law, promote inclusivity through the use of generic personal pronoun references, increase City-wide operational efficiency by eliminating references to outdated business practices, and correct grammatical, punctuation, and spelling errors? Administrative title: Anti-Nepotism policy (proposed new Charter Section 609)	
Shall the Cerritos City Charter be amended to add Section 609, which would prohibit the employment or appointment by the Mayor, City Councilmembers, or City Manager of their relatives by blood or marriage within the third degree, as defined?	YES

Administrative title: City Council Term Limits - Remove all existing term limit provisions
