NOTICE IS HEREBY GIVEN that a General Municipal Election will be held in the City of Cerritos on Tuesday, April 12, 2022, at which there will be submitted to the voters the following Measures:

Administrative title: Comprehensive Charter "clean-up," update and modernization	
Shall the Cerritos City Charter be amended to remove or modify provisions based on superseding and preemptive State law, promote inclusivity through the use of generic personal pronoun references, increase City-wide operational efficiency by eliminating references to outdated business practices, and correct grammatical, punctuation, and spelling errors? Administrative title: Anti-Nepotism policy (proposed new Charter Section 609)

NOTICE IS FURTHER GIVEN that, based upon the time reasonably necessary to prepare and print the arguments and Voter Information Guide for the election, the City Clerk/Elections Official has fixed **Thursday, January 27, 2022, during regular office hours, as posted**, as the date after which no arguments for or against the City measure(s) may be submitted to the City Clerk/Elections Official for printing and distribution to the voters as provided in the Article 4. Arguments shall be submitted to the City Clerk/Elections Official, accompanied by the printed name(s) and signature(s) of the author(s) submitting it, or if submitted on behalf of an organization, the name of the organization, and the printed name and signature of at least one of its principal officers who is the author of the argument, at the Office of the Cerritos City Clerk/Elections Official, 18125 Bloomfield Avenue, 1st Floor, City Hall, Cerritos, California. Arguments may be changed or withdrawn until and including the date fixed by the City Clerk/Elections Official which is **Thursday, January 27, 2022, during regular office hours, as posted**.

NOTICE IS FURTHER GIVEN that any ordinance, impartial analysis, or direct (primary) argument filed under the authority of the elections code will be available for public examination in the City Clerk/Elections Official's Office for not less than 10-calendar days from the deadline for the filing of the arguments and analysis(es).
